All lessees must carry their own liability and loss of property insurance – minimum \$2 Million with Niagara Regional Agricultural Society listed as 3<sup>rd</sup> party. A copy needs to be on file at the NRAS office by **June 1<sup>st</sup>**.

**And, an Inspection must be completed by the Fire Department - 905-735-1700 ext 2403.**

**Indoor Vendor** – 10x10 space - \$90, Corner 10x10 \$120 (**includes 13% HST**) Hydro required? \_\_\_\_\_  
Must provide own extension cords. NO VEHICLES allowed in buildings – must use carts to transport items within building.

**Outside Vendor (non-food)** – 10x10 space - \$120 (**included 13% HST**) Hydro required? \_\_\_\_\_
